

Message from the President

Foreclosure/Eviction Assistance

During the holiday season, most people look forward to spending time at home with family and friends. Other people are not as fortunate and are facing the possibility of losing their most valuable asset, their homes. Some are faced with eviction and others foreclosure. Foreclosure is the legal means by which a lender can repossess a home. In an article published by WTOP, Jeff Clabaugh stated that in

2018, the Maryland foreclosure rate was .86 percent, double the national average, and the third highest among states, behind New Jersey and Delaware. Additionally, Baltimore has the ninth highest foreclosure rate amongst US cities. However, foreclosure filings nationwide, including default notices, auctions and bank repossessions, fell to the lowest level in 13 years. Several legal services organizations offer resources to homeowners and renters in need of free or low-cost legal representation. Those agencies include, Maryland Legal Aid, The Pro Bono Resource Center, Maryland Volunteer Lawyer Service, and the St. Ambrose Housing Aid Center. While this month's article is dedicated to housing programs, Maryland Volunteer Lawyer's Service has a robust housing and eviction program that is worth special mention.

St. Ambrose Housing Aid Center

The St. Ambrose Housing Aid Center provides legal services to include foreclosure defense, landlord-tenant disputes, tax sales, title issues, reverse mortgage default. Additionally, St. Ambrose has been supported by the Baltimore Bar Foundation.

Public Justice Center

The Public Justice Center has the Human Right to Housing Project. They defend renters facing eviction, and advocate for equitable and sustainable affordable housing. They attorneys at PJC may educate tenants about their rights and help them find a solution for eviction.

Maryland Volunteer Lawyer's Service (MVLS)

MVLS is a private, non-profit legal services provider established to provide civil legal representation in Maryland. It offers a wide range of legal assistance including family law, bankruptcy, consumer protection, and housing. MVLS has several programs dedicated to helping people stay in their homes, and is the largest pro bono legal services provider in the state of Maryland. It has approximately 2,600 attorneys on its panel, and has served more than 85,000 clients since their founding in 1981. MVLS volunteers help approximately 5,000 low -income residents and MVLS accepts a variety of housing related cases including landlord/ tenant disputes, foreclosure and tax sale, deed changes, ground rent, and other property related issues. Since 2008, MVLS has participated in the statewide Foreclosure Prevention Pro Bono Project. Through this project, MVLS volunteers represent homeowners in foreclosure cases in court and mediation. Additionally, a foreclosure clinic is currently held once a month in downtown Baltimore and at the Circuit Court for Anne Arundel County. These clinics provide brief advice to any homeowner facing foreclosure or foreclosure mediation.

Project Household

According to the MVLS 2019 Annual Report, MVLS has increased outreach and legal assistance to elderly Marylanders by emphasizing estate planning as an "essential tool for maintaining housing, minimizing opportunities for financial exploitation, and stabilizing low-income communities." MVLS offers several legal resources to help senior citizens maintain their homes. Through Project Household and Housing Upgrades to Benefit Seniors (HUBS), social workers visit the homes of seniors to identify potential housing assistance needs. Once legal needs are identified, the social workers connect home owners to one of several Project Household legal partners including MVLS, Maryland Legal Aid, Pro Bono Resource Center, and Senior Legal Services.

My Home, My Deed, My Legacy

Through their work to keep seniors in their homes and help them obtain needed repairs, MVLS realized that many low-income homeowners in Baltimore City are not listed on the deed to their homes. In partnership with the Maryland Department of Housing and Community Development, MVLS launched the My Home, My Deed, My Legacy Program. The objective of this program is to raise awareness about the importance of homeowners having their names on the deeds to their homes. "The majority of homes in Baltimore City pass through generations without anyone taking the necessary steps to save the family home for the next generation. It is important that people have their names on the deeds to access home repair programs to help make their homes safe." Furthermore, without having their name on the deed, homeowners are precluded from accessing the Homeowners Property Tax Credit, which can help seniors avoid foreclosure or tax sale. A testament to both needs and success, the program will expand in 2020. MVLS recently hired an attorney to focus on cases involving "tangled titles", build volunteer capacity to take such cases, and to increase public awareness about deed issues.

Young Lawyers' Division Report

Making the Most of a Mentoring Relationship



The YLD's Mentoring Committee was created in 2016 to facilitate strong mentor/ mentee relationships among Bar Association of Baltimore City members and the professional development of young lawyers. The Mentoring Committee recently finished connecting 24 new mentor/mentee pairings and held its first event of the year, a joint networking happy hour with the Membership Committee at City Café. Attending this event led me reflect on the mentor/mentee relationships I have had over the

years and what I have learned from them.

In my experience there are three important aspects to a great mentor/

mentee relationship – (1) an experienced and connected mentor, (2) with a personality, values and experiences that are compatible with those of the mentee; and, perhaps most importantly, (3) an eager and committed mentee.

The mentor's experience and connections are the easiest aspects to quantify and a good starting place in choosing a mentor. If a mentee is seeking to build their relationships or involvement in the Bar

Association, for example, a mentor who is an established member of the Bar Association is a smart and easy connection to make. Making a good match becomes more difficult, however, when also trying to find a mentor with common traits, values and experiences to the mentee.

Some lawyers are technical, detail oriented people. Some lawyers excel at business development and networking. There are others who have a passion for advocacy and are mission driven, without regard to the business of law. Some are highly influenced by their faith and values. Others are passionate about fields other than the law, and incorporate those passions into their law practice. Some lawyers have scraped and struggled through every phase of life to get where they are. Some have carefully calculated every step of their career, while others have lucked into their positions or followed the path of least resistance. I do not point out these differences for the purpose of elevating the path of one person over another. The point is that a good mentoring relationship is built on more than common fields of law, law schools or office space.

YLD Member Spotlight

Aureen Edobor is a co-chair of the YLD's Public Service Committee, which is responsible for planning the annual Holiday Party for Children Living in Shelters at the Maryland Science Center on December 10th. Each year the Public Service Committee splits duties between the co-chairs, with the incoming co-chair tasked with orchestrating the Children's' Holiday Party. This year, that task falls on Maureen. In addition to her busy workload as a litigation associate at Nelson Mullins, You can have a highly motivated and capable mentee, and an extremely talented and connected mentor, but if one is shy but brilliant, and the other is a talented sales person who would excel any field of business, it is likely not going to be a fruitful relationship. The values of the mentor and the things that have let to their success are not necessarily going to be things that would benefit the mentee. Of course, these types of things are hard to quantify and do not easily lend themselves to a questionnaire or review of a mentors bio. So it is important to try to dig down into the character and values of the mentor and mentee. This can be done prior to establishing the relationship, if possible, but should also be something that the mentor and mentee are analyzing throughout the relationship to determine whether it makes sense to continue or to seek a better fit elsewhere.

The third and final aspect of a successful mentoring relationship falls primarily on the mentee. The mentee needs to take the relationship seriously and be prepared to get the most out of it. The mentee needs to consider

> exactly why they are seeking mentorship and what they hope to get out of the relationship. They should be prepared to express their goals to the mentor. This helps the mentor determine whether they are capable and willing to meet the expectations of the mentee, and to come up with a plan for doing so. It will help to keep the relationship from meandering or losing focus.

The mentee also needs to make an effort to seek the counsel and wisdom of the mentor. The relationship should be about more than just having lunch and chatting about your interests and activities. A mentor should provide guidance to the mentee, and they cannot do that unless they know what problems the mentee has and what advice would be helpful. When a mentee is busy or lost and not sure what you they are doing, it is difficult to share that with someone else. But the guidance that comes at these times of need is one of the great benefits of a mentoring relationship, and it also helps to strengthen the bond between mentor and mentee. The mentee needs to keep the mentor in mind and be willing to turn to them for guidance.

Finally, I want to thank all the current and former mentors that are reading this. Mentors take one of the most precious commodities in our field of work and life . . . time, and donate it to their mentees. That deserves respect and appreciation. Lawyer in the Library's Success Paves the Way for New Pro Bono Program in City Schools

The lobby at 500 East Lexington Street is always busy on Monday, Wednesday, and Friday mornings; these are walk-in intake days at Maryland Legal Aid (MLA), when potential clients are initially interviewed and advised by paralegals and attorneys. When civil unrest shook Baltimore in 2015, advocates realized that, in spite of the packed lobby each week, many residents remained unaware that MLA could provide free civil legal assistance. Lack of access to public transit or child care; fear of the justice system; disability or illness; all of these factors contribute to a potential client's inability to seek legal help. Additionally, many clients do not recognize that their problems with things like food stamps, child support, or unsafe housing have potential legal, court-ordered remedies.

Lawyer in the Library

The Enoch Pratt Free Library branch on Pennsylvania Avenue in West Baltimore is a community hub; residents of the Sandtown-Winchester neighborhood visit for workforce development, family activities, internet access, and more. And, since 2015, residents can also access legal services at Pennsylvania Avenue, as well as seven other library branches throughout Baltimore. Anyone who is eligible for Legal Aid services can walk in and talk to a lawyer for free during one of MLA's scheduled clinics. Lawyer in the Library, now the program's official name, was MLA's solution to the limitation of the brickand-mortar lobby; a way to remove impediments and meet clients where they already live and work.

Since its inception, the Lawyer in the Library program has helped thousands of clients with civil legal issues and grown from a staff of zero to a dedicated staff of 11. In addition to adding staff, the program has grown because of support from the private bar. With 25 to 30 clinics per month; the staff simply could not support this work without its committed volunteers. The clinic model is a good fit for busy attorneys. Most clinics last two hours; they are offered on both weekdays and Saturdays, at a variety of times; so there is an option for every schedule. Many attorneys choose to attend one clinic a month

or quarter to give brief advice or to help with simple wills or expungements. For practitioners who wish to gain litigation or appellate experience, the option to engage in full representation is available as well. With time, MLA's community lawyering practice has grown not only geographically (there are clinics in almost every county) and by clinic size (the largest clinic took place at Tree of Life Christian Ministries in Prince George's County in 2018, where staff and volunteers filed 791 expungement petitions for 209 people), but also in scope, with clinics on buses, in workforce centers, in hospitals, and ultimately, in 2019, in schools.

Lawyer in the Schools

Standing with Our Neighbors is a school-based legal program in Atlanta, Georgia. In 2018, Gustava Taler, MLA's Chief Operating Officer, saw a news segment on the program, which is facilitated by the Atlanta Volunteer Lawyers Foundation. The program placed lawyers in public schools to stabilize families and reduce the student enrollment turnover resulting from landlord/tenant and other housing issues. Ms. Taler saw a correlation between the project and MLA's community work. MLA staff consulted AVLF several times throughout 2018 and also connected with a program in West Virginia that has a similar lawyer/school model for advice on starting a Baltimore-based school model. From there, MLA submitted a pro-

posal to the Legal Services Corporation (LSC) in early 2019, hoping to secure a Pro Bono Innovation Fund (PBIF) grant to fund a school lawyer project. The PBIF awards grants to programs that use an inventive, forward-thinking approach to engage pro bono assistance and narrow the justice gap. MLA proposed to hire two full-time staff (an attorney and a paralegal) to facilitate clinics in schools in partnership with pro bono assistance from Baltimore area law firms. LSC endorsed the proposal and the project kicked off in October with nine Baltimore City public schools. Each school hosts two clinics per month with the assistance of its law firm partner. MLA staff are always present to assist both clients and volunteers. The clinics are similar to the Lawyer in the Library model; they are first-come, first-serve and last two hours. They differ in that the school clinics are open only to parents of children attending the school, with the exception of Mergenthaler Vocational Technical High School, which is open to all community members. In all, MLA is partnering with 11 public schools, nine through the PBIF grant and two others.

Baltimore City Public Schools offer much to their communities beyond educating children. "Food and Fellowship" is a program at New Song Elementary School in West Baltimore. The program will include a free meal, a chance to meet with a health care provider via Medicine for the Greater Good, a Johns Hopkins subsidiary, a chance to consult with an attor-

ney from Maryland Legal Aid, and other services. This wraparound approach is not atypical. Much like public libraries; schools are finding innovative ways to address community problems. Cherry Hill Elementary School has partnered with area farmers to provide free groceries; Mergenthaler offers students a chance to learn more about the legal world in its Law and Leadership Class. Another school has a partnership with the Baltimore Ravens to help with school uniforms and several schools partner with area medical facilities to provide health care to families. Social workers help both students and parents deal with trauma. These schools are often the only place com-

maintaining housing, and other issues directly affecting the lives of seniors, says Woolums.

In October, the organization held its annual fundraising event "Cabaret & Cabernet" at Westminster Hall, featuring a cast of attorneys, judges, and friends of the Bar Association of Baltimore City and honoring Volunteers of the Year Award Recipients Jan Berlage and Sandra Gohn. The event funds the very popular "Law Day for Seniors," which will take place on April 18, 2020, and includes informational sessions for seniors on aging in place, housing issues, access to services, and avoiding financial scams. Seniors are able to speak with vendors from dozens of organizations throughout Baltimore City and ask questions of a panel of attorneys. They also receive breakfast and lunch during the all-day seminar.

Last year, Woolums says Senior Legal Services closed about 1,500 cases through the work of staff members and pro bono attorneys. The organization provides training for volunteers through Project Household (a joint venture with other local legal services providers funded by The Leonard and Helen R. Stulman Charitable Foundation), as well as mentorship, and legal malpractice insurance for volunteer attorneys.

Every quarter, Senior Legal Services partners with Exelon & McGuireWoods to hold clinics where volunteers can assist clients in preparing a will, advanced directive, and power of attorney. "This is an opportunity to have direct client interaction and perform useful work during a discrete session," says Woolums.

Woolums says she and her colleagues have recently seen an uptick in queries regarding Real ID compliance. Many seniors have insufficient or inconsistent documentation to obtain a Real ID, and may need help facilitating a name change or obtaining a birth certificate or overcoming other barriers in order to renew their identification, which may have ramifications in terms of access to services or federal buildings, says Woolums. This is an area where volunteers can assist clients in a way that "means a lot to them," says Woolums, without undertaking a matter involving heavy litigation.

Exelon: A Good Corporate Citizen

Since stepping into her term as President of the Bar Association of Baltimore City a few months ago, Judge Middleton has stressed the importance of access to justice and pro bono service. While she continues to encourage members to assist and provide resources to those in need, several members of the legal community are leading the charge to further access to justice and legal services for all. Paul Ackerman, Associate General Counsel at Exelon Corporation, and his colleagues in Exelon's Legal Department have recognized the importance of getting out into the communities serviced by their utilities and have undertaken pro bono work for years. In fact, Exelon and its local affiliates, Baltimore Gas & Electric and Constellation, have a strong corporate commitment to pro bono service and provide structure and support through an enterprise-wide pro bono committee



for their employees to find pro bono opportunities. Some corporate attorneys volunteer in their areas of expertise by volunteering on a board or doing related corporate non-profit advising, while others find something unrelated to their work, such as drafting wills, representing unaccompanied minors in immigration cases, or attending a pro bono clinic.

Notably, since December 2013, Paul and his colleagues have volunteered with Senior Legal Services ("SLS"), a joint program of the Bar Association of Baltimore City and Baltimore Bar Foundation, Inc. that provides free legal advice, services, and representation to Baltimore City residents age sixty and older. In 2013, as a new Co-Chair of Exelon's pro bono committee, Paul talked with SLS about an interest in partnering to do pro bono work. Paul and SLS, supported by Cecil Martin at McGuireWoods LLP, collaborated to create

a sustained clinic to bring Exelon and McGuire Woods volunteers and other resources into the community to support low-income seniors. Through SLS's flexible pro bono options, Exelon customized an easy and rewarding recurring clinic opportunity that accommodated the schedules of volunteers while providing needed services to an underserved segment of the population in Baltimore City.

The results have been fantastic. At each clinic, Exelon and McGuireWoods have ten to twenty volunteers, including lawyers, notaries, paralegals, and administrative staff, who are supported by estate planning experts affiliated with SLS to provide services to clients. Even retired Exelon attorneys come back to support the clinics and volunteer for SLS. In one halfday clinic, Exelon and its partners can fill out fifteen to thirty wills, financial powers of attorney, and advanced medical directives using a handbook that guides volunteers through the process. In addition, once per year, Exelon holds a larger clinic where all of its staff spend one-half of a workday volunteering at a clinic. These annual "all hands" clinics usually have fifty to sixty lawyers and professionals in attendance. Paul does not have a problem getting his colleagues to participate in the clinics because people typically begin asking about the next clinic as soon as the current one is finished.

Since the first clinic held in December 2013, Exelon has partnered with SLS and McGuireWoods on twenty-two clinics, usually holding one clinic per quarter. Through these clin-



ics, Paul and his colleagues have served 418 clients and drafted 806 estate-planning documents. At the most recent clinic in September, ten in-house counsel from other companies in Maryland who are members of the Association of Corporate Counsel Baltimore Chapter joined Paul and other Exelon and McGuireWoods volunteers. For some of these corporate attorneys, the clinic with Exelon was their first time doing pro bono work.

Paul and Exelon strive to encourage others to experience the fulfillment of pro bono service. As Paul notes, working with SLS gives attorneys an opportunity to get out from behind their desks and into the community. Company- or firm-supported clinics also give attorneys and other staff a great first exposure to pro bono work where they have fun with their colleagues and connect with clients.

Exelon has received several awards for its pro bono efforts. Just this past summer, Exelon received the Corporate Law Department of the Year Award from Maryland Pro Bono Resource Center for recognition of its efforts with SLS and other organizations. Paul and his colleagues were grateful and proud to be recognized with the award and look forward to continuing to participate in clinics with SLS.

Spotlight on Project HEAL

Project HEAL (Health, Education, Advocacy, and Law) is a community-based program of the Maryland Center for Developmental Disabilities (MCDD) at Kennedy Krieger Institute. Project HEAL is Maryland's only comprehensive medical-legal partnership. Project HEAL provides advocacy and legal services for children with intellectual and developmental disabilities who are patients at Kennedy Krieger Institute and their families. Attorneys at Project HEAL collaborate with Kennedy Krieger faculty, staff, and trainees to ensure that patients receive the medical and legal care they need. Attorneys review all cases to determine if there is a civil issue that requires representation. For cases that do not require the intervention of an attorney, Project HEAL attorneys provide limited representation, which includes services such as providing referrals, document review, and brief advice.

In addition to Project HEAL attorneys' representation of students with disabilities, Project HEAL partners with four law firms -- Baker Donelsen, Ballard Spahr, DLA Piper, and Offit Kurman -- to provide legal services to additional families. Michael Cianfichi, an associate from one of Project HE-AL's law firm partners, played a vital role in securing appropriate special education and related services for children with

intellectual and developmental disabilities. Cianfichi recounts his experience assisting one client: "In 2016, I partnered with Project HEAL to represent a young student with disabilities in regard to her educational rights, and successfully obtained a more appropriate educational placement for her. We at the firm were excited for the opportunity to work with Project HEAL on a local issue that could have such an important effect on the student and parent's lives. The attorneys at Project HEAL were an incredible resource for us during our representation. They were happy to lend their expertise to answer any of our questions and were always promptly responsive. In the course of our representation, we attended several individualized education program (IEP) meetings with the parent, diligently analyzed the student's progress to document the school system's failures, worked with the student's Kennedy Krieger clinicians to identify the appropriate recommendations, and drafted formal letters to the school system exposing the problems going on at the student's school. We were pleased to obtain a favorable result for the student and we look forward to working with Project HEAL again in the future."


