With Mothers' Day just around the corner, and being my first one as a mommy, it seemed like a good time to reflect a bit on being a lawyering

2023 brought some new roles into my life. As I celebrated ten years of being in

Our life comes in segments, and we have to understand that we can have it all if we're not trying to do it all at once." I never fully understood this quote until now.

help with a project, I suddenly found myself in a position where I actually had to say no to taking on 'just one more thing.' If I'm being honest, finding balance is probably still a ways off, and some days are particularly challenging, especially when imposter syndrome rears its head. It's easy to feel like I'm not accomplishing everything I set out to at the start of the day, and I'm still learning that some choices are easier than others—like setting my work down earlier in the evening to have extra cuddles with Alex. Other choices in the future may include taking the BABC's littlest member to an event with me, but I know I wouldn't have some of those choices without the incredible YLD team who have made the transition to Chair while mommying much more graceful than it could have been. And while he's not talking just yet, I know Alex is grateful too.
